Open letter to all members of the Danish Parliament, the power of justice and the 4th state-power (the media)

Cease and desist: Calls for immediate actions to be taken against covert crimes committed against innocent citizens in Denmark

Due to the nature of the crimes I've been exposed to in a very life-threatening manner since 2016, involving the use of wireless radio-communication and nanotechnologies, RFID technologies (radio frequency identification technologies) including body-chipping and other harmful violent acts against my body, privacy and peace of mind, I'm sending this letter to the members of the Danish Parliament and others.

I am aware that the UN has asked its stakeholders, including Member States for inputs concerning *the study of the Human Rights Council Advisory Committee on neurotechnology and human rights (HRC resolution 51/3)*:

"in order to prepare a study on the impact, opportunities and challenges of neurotechnology with regard to the promotion and protection of all human rights, including recommendations on how human rights opportunities, challenges and gaps arising from neurotechnology could be addressed by the Human Rights Council and its special procedures and subsidiary bodies in a coherent, holistic, inclusive and action-oriented manner..." (UN, 2023).

I'm therefore sending a brief update concerning my situation, which involves organized crime and the harmful use of nanotechnologies inside my body through the use of radio frequency communication: Crimes which have been going on for years, without the police or any other Danish state-institution doing any investigation in connection to my case or assisting me in any other way, with devastating consequences for my life and others around me. Among the major symptoms I'm suffering from as a result of these crimes are – EHS (electro hyper sensitivity) and pulmonary disease – both well known diseases related to the use of nanotechnology and wireless communication technologies. I have also been under suspicion for heart-problems and other health-issues which began immediately after I was exposed to this sort of covert criminality in Denmark in 2016: Crimes related to *the war on terror* and *terrorist watch-lists* according to

international sources who are aware of these crimes, besides human experimentations on unwilling and often unknowing citizens and other motives such as hate-crimes etc. – or what sometimes appears to be just plain amusement.

Today I'm therefore able to present evidence of the crimes I've been exposed to for years, involving the use of nanotechnologies (that could for instance be neural dust) which are being used in a life threatening manner by criminals and corrupt people within Denmark and others as part of an international agenda.

My doctor has been trying to get the hospitals to take actions, but nobody wants to address these crimes (I'll attach one of her letters to the Danish hospitals concerning nanotechnologies). This toxic situation in Denmark has led to, that others around me are now also being affected by these crimes (I'm especially concerned about *names deleted*) because the police repeatedly has chosen not to take action – an obvious gap in the justice system and a gateway for criminals to commit their crimes without consequences – affecting innocent people and destroying lives and families.
