**Concerning neurotechnology and human rights (HRC resolution 51/3) deadline July 2<sup>nd</sup> 2023:**

***1. A brief overview seen from my perspective as a victim of the misuse of neurotechnologies and violation of human rights in Denmark:***

As member of the civil society in Denmark and as an individual directly affected by the misuse of neurotechnologies against innocent civilians, I would like to make a brief comment concerning neurotechnologies and human rights.

I'm an involuntary subject of the misuse of neurotechnologies (nanotechnologies, implants and such) inside my body – a situation I became aware of in 2018 and which escalated in 2020 along with the rollout of 5G.

Some may call it unwilling experiments on humanity and/or human trafficking? I call it a violation of human rights, since these technologies are a violation of all human rights imaginable – both concerning health, wellbeing, privacy (including the term *Cognitive Warfare*) and constant tracking of my whereabouts.

I have tried to go to the Danish Police who have rejected all my evidence concerning these covert crimes involving the misuse of *Radio Frequency Identification* (RFID) technologies aka neurotechnologies, besides other forms of cybercrimes, surveillance and harassment.

I have tried to write to the politicians and Secret Service whose only response has been to contact the police.

I have tried to go through the medical system, but except from my doctor and a dermatologist, no hospital will have anything to do with either the evidence of nano/neurotechnologies or treat the matter as such.

The answer in many cases has been: "We know nothing about nanotechnologies – and there is no scientific evidence for these technologies." Replies that indicate a huge ignorance within the medical system.

I have even tried to contact the Human Rights Organization in Denmark and their answer was that my situation was beyond their mandate.

Bottom line: I haven't had any qualified help yet, besides the help from my doctor and dermatologist who have both tried to get me inside the hospital system without any major success.

*2: Health-consequences:*

The consequences are already serious and I have often been seeking immediate medical care at hospitals, sometimes requiring hospitalization for especially pulmonary issues: low oxygen in the blood, pneumonia and difficulties breathing without the doctors being able to measure any inflammation or infection in the blood (through measuring CRP levels in blood-tests) which at least should raise some question concerning the issues behind my symptoms since pneumonia causes infection in the blood.

In 2021 I was diagnosed with *chronic-obstructive-pulmonary-disease*. A diagnose which have since been modified to *asthma* and *chronic obstructive pulmonary disease "dispositions"* – since the treatment for *chronic obstructive pulmonary disease* have had no effect on me, which also should raise some questions about the nature of my health-problems.

However, I haven't been able to get the necessary help either from the hospitals or any other state-institution – even though pulmonary diseases are known as common side-effects connected to neuro/nanotechnologies.

In 2020 I also got the diagnose *Electro, Hypersensitivity* another diagnose related to the wireless society and misuse of neurotechnologies, which Denmark doesn't recognize as a legit diagnose. The conclusion is that I've been unable to receive any help from the Danish State and society in general concerning neurotechnologies. Furthermore, I'm unable to reject the wireless society (aka smart meters, 5G on/or nearby private properties or any other initiatives which would dramatically reduce the misuse of wireless communication with RFID technologies) as a citizen in Denmark.

So, the situation in Denmark is critical concerning human rights, and I have no opportunities but to turn to the UN for further regulation of the violation of human rights in Denmark and globally.
